



2023 Eastern European Equine Practitioners' Congress Regulations

§1

General provisions

1. These Regulations have been established for the purpose of defining the rules of participation in the Eastern European Equine Practitioners' Congress, which will be held 13-14 May 2023 in Poznań and organized by "Sassebi Alina Palichleb" Publishing House.
2. The following terms and acronyms are used in these Regulations:
 - a. Congress or EEEPC – Eastern European Equine Practitioners' Congress, held in Poznań 13-14 May 2023;
 - b. Participant - a person who has registered and paid for their participation in the Congress in accordance with the provisions of these Regulations;
 - c. Organizer - Sassebi Alina Palichleb conducting business activity registered in the Central Business Register (Centralna Ewidencja i Informacja o Działalności Gospodarczej), with its registered office in Kraków, at ul. Zygmunta Miłkowskiego 6/42, 30-349 Kraków, entered in the Register of Active VAT Payers: NIP 6762213507, REGON: 121132251,
 - d. Partners - Co-organizers, Sponsors, Exhibitors and other entities participating in the Congress;
 - e. Civil Code - the law of April 23, 1964. - Civil Code (unified text, Journal of Laws of 2020, item 1740, as amended);
 - f. GDPR - Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free flow of such data and repealing Directive 95/46/EC (OJ L 119, 4.5.2016, p. 1-88, GDPR), as well as the Act of 10 May 2018 on the protection of personal data [i.e. Journal of Laws of 2019, item 1781 - as amended, UODO] - Polish regulations adopted to enable the application of GDPR; the GDPR Privacy Notice for Congress Participants is provided in Appendix No. 1 to the Regulations;
 - g. TPay - an electronic payment system which allows users to make quick pay-by-link payments, offered by a company operating as Krajowy Integrator Płatności S.A., with its registered office in Poznań, 61-894 Poznań, Plac Andresa 3, 17th floor, entered in the National Court Register, KRS No.: 0000412357;
 - h. Appendix No. 2 to the Regulations - Pricelist for Congress participation.
3. The provisions of these Regulations along with Appendix No. 1 and Appendix No. 2 shall be applicable to participation in the Congress, including in the event its date or venue should change.
4. All information pertaining to the Congress can be obtained from the Organizer via e-mail at info@eeepc.org.
5. The EEEPC is a closed professional event and shall not constitute a mass event as stipulated by the Law on Security of Mass Events of March 20, 2009 (Journal of Laws 2022, item 1466, as amended).



6. It is necessary to read and acknowledge these Regulations as a prerequisite for participation in the Congress. Registration for participating in the Congress is synonymous to the acceptance of the Regulations.

§2

Registration for the Congress and payment

1. Participants can take part in the Congress at the venue of the Congress (on-site formula) or online, i.e. online streaming service prepared by the Organizer (online formula).
2. Only adults who also meet the criteria indicated in the Regulations may participate in the Congress. The Congress is addressed to persons engaged economically and professionally in a given field indicated in point 3, including students / academics in a given thematic path. The Congress is not intended for people interested in a given field of knowledge as a hobby or amateur.
3. The Congress agenda is structured into three thematic pathways dedicated to separate professional groups:
 - a. veterinarians,
 - b. farriers,
 - c. physiotherapists and veterinary technicians.
4. When registering, the participant chooses one of the indicated thematic pathways. It is not possible to change the thematic pathway after the application has been submitted and paid for. The participant is required to choose a pathway that is consistent with his/her profession. Upon selecting the pathway indicated in point 3(a) (veterinarian), it is required to provide the right to practice ID in the registration form.
5. Participants enrolled in the pathway referred to in point 3(a) (veterinarian) will be provided with substantive materials from the other pathways.
6. Participants enrolled in the pathways referred to in paragraph 3(b) (farrier) and (c) (physiotherapist and veterinary technician) will be provided with substantive resources related exclusively to their own pathways; pharmaceutical exhibitor space organized as part of the Congress will not be made available.
7. In order to participate in the Congress, it is necessary to register via the registration form available at www.eeepc.org, to provide the mandatory consents in the form and to pay the participation fee. Each participant should independently and on his/her own behalf complete the registration form and express mandatory consents required for registration. The form allows participants to indicate the entity (payer) who makes the payment for the participant and to whom the invoice for the Participant's participation in the Congress is to be issued. If you purchase "duo" tickets, please provide mandatory consents in the form on site.
8. Registration for Participants will open on November 28, 2022, and will close on May 10th, 2023 at 11:59 p.m. The Organizer reserves the right to change the dates of registration, as well as to end it early, for example, if all seats for the on-site participation have been sold out.
9. Within 24 hours, the organizer shall send a confirmation regarding the receipt of the application for participation in the Congress to the address provided in the registration form. This is not synonymous with confirmation of participation in the Congress. Participation in the Congress is



possible after full payment for participation in the Congress has been made (conclusion of the Congress participation agreement).

10. Payment must be settled within 7 days after receiving the confirmation of acceptance of the application for participation in the Congress to the Organizer's bank account, either directly or via TPay. The date on which the fee is credited to the Organizer's bank account shall be considered the date of payment.
11. In the event payment is not made within 7 days of registration, the registration will be canceled.
12. After the payment is credited to the Organizer's bank account, a confirmation of participation in the Congress is sent by email.
13. Reimbursement of the Congress ticket fee paid shall be granted only in the cases specified in these Regulations.
14. Participants and payers agree to issue and receive invoices electronically, to the email address indicated in the registration form. The invoice will be delivered within 7 days after the payment has been credited to the bank account.
15. The Organizer does not provide the Participants with accommodation and transportation, and the fees made in accordance with Appendix No. 2, the price list of additional services available at www.eeepc.org and in the registration form include only the services explicitly indicated therein. Each Participant shall bear the costs of travel and accommodation in connection with participation in the Congress on their own. However, the Organizer informs about the possibility of accommodation in hotels cooperating with the Organizer through www.eeepc.org. Availability of places in hotels may be limited. The Organizer is not responsible for the services offered by hotels, nor for the booking of accommodation.

§3

Congress venue, date and agenda

1. The Congress will be held 13-14 May 2023. The Organizer has the right to schedule a different date for the Congress than the dates indicated herein.
2. The congress will be held in two locations in Poznań: Poznań Congress Center at ul. Głogowska 14, Poznań and additionally for professional farriers at the Wola Hippodrome at ul. Lutycka 34.
3. The Organizer does not provide participants with transportation between Poznań Congress Center and Wola Hippodrome.
4. The Organizer reserves the right to change the date or location of the Congress, as well as, depending on the circumstances, to determine that the Congress will be held, in whole or in part, in an "online" formula.
5. In case of a change in the date, place or formula of the Congress, the Organizer will immediately inform the Participants thereof through www.eeepc.org and by email.
6. In the event that the Congress formula is changed to an "online" formula, the Participant will receive a refund equal to the difference between the price of the Congress in the on-site and "online" formula within a period of no more than one month, as of the date the formula change has been communicated. Apart from the refund referred to in the preceding sentence, due to the change made by the Organizer, the Participant is not entitled to any claims against the Organizer (e.g., for reimbursement of costs incurred in connection with transportation or accommodation).



7. In the event that the date or place of the Congress is changed to a location other than Poznań, the Participant will receive a refund in the amount of 100% of the fee paid by the Participant within no more than one month, as of the date the change of date or place has been communicated. Apart from the refund referred to in the preceding sentence, due to the change made by the Organizer, the Participant is not entitled to any claims against the Organizer (e.g. for reimbursement of costs incurred in connection with transportation or accommodation).
8. The Congress agenda is available at www.eeepc.org. The Organizer reserves the right to change the speakers. In such a case, the Participant shall not be entitled to resignation entitlements outlined in point 5 and point 6 hereof, or any other claims against the Organizer.
9. The Organizer reserves the right to cancel the Congress. In such a case, the Organizer shall refund to the Participant the fees paid by them to the Organizer related to participation in the Congress. Apart from the reimbursement of the fee referred to in the preceding sentence, in connection with the cancellation, the Participant shall not be entitled to any claims against the Organizer (e.g. for reimbursement of costs incurred in connection with transportation or accommodation).

§4

Resignation or change of a participant

1. Cancellation of participation in the Congress for reasons dependent on or beyond the control of the Participant is possible only through a statement of cancellation of participation in the Congress sent by email to info@eeepc.org.
2. If the statement of cancellation is delivered to the Organizer:
 - a. no later than February 28, 2023 inclusive, the Organizer will refund 80% of the paid fee to the Participant, to the bank account number from which the payment was transferred, within 30 days.
 - b. no later than 31.04.2023 inclusive, the Organizer will refund 50% of the paid fee to the bank account number from which the payment was transferred, within 30 days.
3. If the statement of cancellation is delivered after 31.04.2023, or if such a statement is not made and the Participant does not participate in the Congress or any part of the Congress, then the Participant is not entitled to a refund of the fee or other claims against the Organizer.
4. It is possible to change the Participant no later than 14 days before the beginning of the Congress, under the condition that the deadline for applying for a new Participant, completing the registration form available at www.eeepc.org and expressing the mandatory consents in this form is 14 days as of the date on which the Participant sends information about the cancellation and provides information about the new Participant to the email address: info@eeepc.org.

§5

Identification, security and rules applicable at the Congress on site

1. Throughout the Congress, the Participant is obliged to observe the rules of culture, respect the rules of social interaction and comply with the instructions of the Organizer.



2. A Participant holding a badge entitles him/her to enter the Congress events. The badge will be issued to the Participant on the first day of the Congress.
3. It is not permitted that the Participants carry out any commercial, advertising, promotional or campaigning activities, nor any fundraising activities that are not agreed with the Organizer or activities that are not in compliance with the applicable laws.
4. The Organizer is not responsible for any belongings of the Participant that are lost, stolen or damaged during the Congress.
5. It is not allowed for the Participants to record (audio and video recording) the course of the Congress by any audio-visual means without a prior consent of the Organizer.

§6

Identification, security and rules applicable at the Congress online

1. Rules for participation in the Congress online (streaming):
 - a. The participant must have working equipment with HTML5 support and Internet access;
 - b. After applying for participation in the Congress online in accordance with the Regulations and making the required payments, the Participant will receive access to an account that enables participation in the Congress online;
 - c. during the online participation in the Congress, there may be short interruptions in the continuity of the video or audio (e.g. skips, slowed display of images) caused by disruptions beyond the control of the Organizer;
 - d. The participant shall not share the login data with others, nor make the Congress broadcast available to the public, commercially, or to any third party;
 - e. The participant can only be logged in on one device at a time;
 - f. The participant shall bear all costs related to the provision of necessary technical conditions, referred to in the Regulations, for participation in the Congress online.
2. The Organizer shall not be liable for (1) incorrect provision of email address by the Participant during registration preventing participation in the Congress online, (2) failure of the Participant to meet the technical conditions outlined in the Regulations, (3) malfunction of the Participant's equipment, (4) downtime in Internet access on the part of the Participant, (5) lost benefits.

§7

Images of Participants

1. By accepting these Regulations, the Participant, pursuant to Article 81 (1) of the Act of February 4, 1994 on Copyright and Related Rights (Journal of Laws of 2019, item 1231, as amended), agrees that the Organizer may use and distribute his/her image free of charge in case their image is recorded in connection with participation in the Congress (applies only to participation in the Congress on-site). Each Participant acknowledges that the image may be disseminated by the above-mentioned entities, among other things, for the purposes of promoting and informing about the Congress or the Organizer's activities, in any place, time or form (e.g., frame, photo, video), in particular during the Congress, as well as after its completion, in various media, including the Internet, social media (e.g., Facebook, Instagram, LinkedIn, YouTube, in the press), website:



www.eeepc.com. Revocation of permission to use or distribute the image during the Congress will prevent the Participant from continuing to participate in the Congress.

2. In particular, the above consent to the use and dissemination of the image includes the following:
 - a. any reproduction by any technique, including: on audiovisual discs, by light-sensitive technology, by digital means, by computer recording, in a multimedia network (including the Internet),
 - b. processing,
 - c. input into the memory of a computer, the memory of another device and into a multimedia network, including the Internet,
 - d. any dissemination, including in the form of print, digital recording, multimedia broadcast,
 - e. any circulation of the original or copies on which the image was captured - marketing (including through the Internet and other data transmission techniques, using telecommunications, information technology and wireless networks), lending or renting or giving the original or copies for use on the basis of any other legal relationship,
 - f. public screening, exhibition, display, reproduction, as well as broadcasting and re-broadcasting, as well as making it available to the public in such a way that anyone can access it at a place and time of their choosing, in particular on websites, social networks,
 - g. use in multimedia items.
3. Any recording or capturing of the Congress or Participants as well as dissemination of recordings, photographs, publications and other materials obtained in connection with the Congress requires a prior consent of the Organizer expressed in writing under pain of nullity.
4. The Organizer shall not be liable for the recording, capturing or dissemination of the Participant's image by other Participants or by other persons.

§8

Complaints

1. The organizer does not provide any warranty for the services provided as part of and during the Congress.
2. Neither the Organizer nor the Participant shall be liable to each other for failure to perform or improper performance of any obligations under the Regulations insofar as it is caused by a force majeure event.
3. In connection with the provision of Services, the Organizer shall be liable under the general rules of the Civil Code.
4. None of the provisions of the Regulations shall limit the consumer rights or the rights of a single-entrepreneur under applicable laws.
5. A Congress participant has the right to complain in the event of a significant inconsistency of the Congress with its agenda, changes to which have not been previously communicated as stipulated in the Regulations.
6. The Organizer is the entity responsible for processing complaints.
7. A complaint should contain data that make it possible to identify the person submitting it, the subject of the complaint and the demands related to the complaint. The Participant should include the following details in the content of a complaint: his/her identification data, i.e. name and



surname, company (in situations participation is a part of business activity), contact data: e-mail address and telephone number, and a description of the reason for the complaint.

8. In the case where a claim is incomplete, the Organizer will request the Participant to complete the claim under pain of leaving the claim unprocessed.
9. Complaints shall be reviewed promptly, but no later than 30 days from the date of receiving a complete complaint at info@eeepc.org. In the event the aforementioned deadline expires, it does not terminate claims and does not affect the Participant's right to pursue any claims through judicial or extrajudicial proceedings.
10. The Participant shall be informed about the outcome of the complaint review by email at the email address indicated by the Participant.
11. If the Organizer does not acknowledge the complaint filed by the Participant, the Participant may use judicial and extrajudicial means to pursue claims.

§9

Code of conduct

1. In the event that a Congress Participant (whether onsite or online) disrupts the Congress, hinders or prevents the participation of other participants, or otherwise violates the Regulations, the Organizer reserves the right to disqualify such persons from continuing to participate in the Congress without compensation of the Congress participation fee.
2. Participants may stay at the Congress venue only during the dates and times stipulated in the Congress agenda.
3. The Congress venue, halls, booths or other exhibition spaces, as well as passageways in the halls and entrance doors to the halls may be temporarily closed for a short period of time or have restricted access, limited to the number of people who may be in the area at one time, for organizational or security reasons, and may not be accessible to Participants during that time.
4. It is forbidden for the Participants to record (photographing, filming, sound recording) any point of the Congress agenda by any audio-visual means unless the Participant receives appropriate permission from the Organizer. If the above activities may cause disruption in the organization and course of the Congress, the Organizer may issue an order to stop them.
5. It is forbidden for the Participants to carry out any commercial, solicitation, advertising, promotion, as well as agitation and fundraising activities that have not been agreed with the Organizer, as well as activities that are not in compliance with the applicable laws.
6. The following are prohibited at the Congress:
 - a. Bringing in and using weapons, ammunition and explosives, harmful chemicals, as well as open fire, which may pose a fire hazard, damage to property and pose a danger to the health and life of persons;
 - b. Bringing in and consuming alcohol and distribution and use of intoxicants;
 - c. Public disorder (e.g., loud, aggressive behavior);
 - d. Entering with animals, as well as bicycles, etc.;
7. It is prohibited to leave any items, including luggage or other property, unattended.
8. Items and substances specified in point 6(a), as well as items left in the Congress area unattended, may for safety reasons be removed or destroyed by the Organizer or specialized



services at the expense of the person leaving the items/substances unless it cannot be determined to whom they belonged. If it is necessary to evacuate people from the halls or the Congress area, the person who left the items will be charged with the cost of this evacuation.

9. Participants are obliged to:
 - a. respect the signage of traffic routes and zones closed for traffic subject to fire protection;
 - b. comply with the traffic regulations that apply to the traffic zone at the Congress venue;
 - c. carry out the instructions issued by the Organizer's security services for organizational and safety reasons (the need to secure property and ensure the safety of people in the Congress venue), e.g. concerning the evacuation of people;
 - d. carry out the instructions of Fire Department officials or other state services during evacuation, rescue operations or control and investigation activities.

§10

Final Provisions

1. In matters not regulated by these Regulations, the applicable provisions of law, including those of the Civil Code and GDPR, shall apply.
2. These Regulations shall enter into force as of November 28, 2022 and shall remain in effect until repealed.
3. The Organizer is the administrator of the Participants' personal data. Personal data will be processed in accordance with the GDPR. The detailed content of the information regarding the processing of personal data is specified in Appendix No. 1 to these Regulations.
4. The Organizer reserves the right to amend these Regulations, of which the Participants shall be immediately informed.

GDPR Privacy Notice

Pursuant to GDPR obligation, the Organizer Sassebi Alina Palichleb, conducting business activity registered in the Central Business Register (Centralna Ewidencja i Informacja o Działalności Gospodarczej), with its registered office in Kraków, at ul. Zygmunta Miłkowskiego 6/42, 30-349 Kraków, entered in the Register of Active VAT Payers: NIP 6762213507, REGON: 121132251 hereby provides information regarding the processing of your personal data in connection with your participation in the Eastern European Equine Practitioners' Congress (hereinafter referred to as "Congress").

1. Your data shall be administered by the Congress Organizer - Sassebi Alina Palichleb conducting business activity with its registered office in Kraków, at ul. Zygmunta Miłkowskiego 6/42, 30-349 Kraków, entered in the Register of Active VAT Payers: NIP 6762213507, REGON: 121132251, e-mail: info@sassebi.pl (hereinafter referred to as "Administrator").
2. Available on the Congress website (www.eeepc.org), the participation application form includes fields for consent regarding the processing of personal data:
 - a. Consent to the processing of personal data provided in the application form for the purpose of participation in the Congress (including: name, title, e-mail address, telephone, company name, company address, NIP tax number, country) - this consent is mandatory and failure to provide the consent will deem it impossible to participate in the Congress. The data specified in the form is necessary to ensure the organization and conduct of the Congress, including confirmation of the reservation of your participation in the Congress, settlement of payments, preparation of badges, etc. The indicated personal data will be processed for the period necessary to settle the Congress and until potential property claims become void, as well as until the expiration of deadlines specified in the accounting regulations. The legal basis for the processing of personal data resulting from the application form is Article 6(1)(b) of the GDPR;
 - b. Consent to the processing of your image in connection with your participation in the Congress on site - this consent is mandatory and failure to provide the consent will deem it impossible for you to participate in the Congress on site. The consent is necessary as the proceedings of the Congress will be recorded and documented and materials from the Congress may be disseminated in accordance with § 6 of the Regulations. The indicated image may be processed (disseminated) until you revoke your consent to the processing of personal data (revocation of consent does not include, in particular, promotional materials broadcast before the date of revocation). The legal basis for processing the image as personal data is Article 6(1)(b) of the GDPR;
 - c. Consent to receive email newsletters from the Administrator - this consent is voluntary, however, failure to provide it will prevent the Administrator from delivering newsletters to you. The purpose of granting this consent is to keep you informed about the Administrator's activities. The Administrator will be able to send you the aforementioned information and materials until you revoke your consent to receive the newsletter. The basis for the processing of personal data is Article 6(1)(a) of the GDPR - voluntary,



unambiguous, informed and specific consent of the data subject. Consent revocation does not affect the legality of the processing that was carried out on the basis of consent before its revocation.

3. Your personal data provided in the online application form may be transferred to the Partners and Co-Organizers of the Congress for statistical or Congress-related purposes.
4. Additionally, irrespective of point 4 above, your personal data may be shared with Partners for the fulfillment of the Partner's marketing purposes as data controller provided that you give your consent in the appropriate field in the application form. Your consent is voluntary and failure to provide it will result in your personal data not being provided to Partners, Sponsors and Co-organizers for purposes relating to marketing. The basis for the processing of personal data is Article 6(1)(a) of the GDPR - voluntary, unambiguous, informed and specific consent of the data subject. Consent revocation does not affect the legality of the processing that was carried out on the basis of consent before its revocation.
5. Subject to point 4 above, your personal data will not be disclosed to third parties unless it is necessary for the fulfillment of a contract. The Administrator may disclose this personal data to entities providing IT, security, legal, accounting, postal, courier, payment companies, hotels, etc. services on its behalf.
6. As regards the data referred to in point 2(a)(b) hereinabove, your personal data will be processed for the duration of the agreement unless a longer processing period is necessary, e.g. due to archiving obligations, claims, etc. In the case of the data indicated in point 2(d) and point 4 hereinabove, the data will be processed until you revoke your consent in the given scope.
7. You have the right to withdraw the consents provided at any time. Consent revocation does not affect the legality of the processing that was carried out on the basis of consent before its revocation.
8. Unless otherwise stipulated by applicable laws, you have the right to request access to data, rectification, deletion or restriction of data processing, data transfer, and to object to having your data processed.
9. You also have the right to file a complaint to the supervisory authority - the President of the Personal Data Protection Office (ul. Stawki 2, 00-193 Warszawa).

 - b. coffee breaks and lunches on 13 and 14 May 2023 as part of the veterinarian and physiotherapist/veterinary technician pathway and 13-15 May 2023 as part of the farrier pathway,
 - c. an ID badge, certificate of participation, conference materials in a digital format online,
 - d. simultaneous translation of substantive parts of the Congress into Polish,
 - e. access to the exhibition area,
 - f. three-month access to online materials from the Congress.

2. The following are included in the price for participation in the congress online:
 - a. participation in all events within the official agenda of the Congress online via web streaming prepared by the Organizer,
 - b. certificate of participation, conference materials in a digital format online,
 - c. simultaneous translation of substantive parts of the Congress into Polish,
 - d. three-month access to online materials from the Congress.

3. During the registration process, the participant can request for additional services made available at the Congress, which are subject to additional fees. A detailed price list of these services will be available at www.eeepc.org and in the registration form.
 The additional options specified include:
 - a. participation in the Evening Gala,
 - b. printed conference materials,
 - c. child care,
 - d. participation as a guest attendee on the third day of the Congress (for veterinarians and physiotherapists/veterinary technicians)
 - e. and others; however, the Organizer reserves the unilateral right to change the list of additional services available to Participants.

4. All conference materials distributed to a participant in relation to the Congress are the property of the Organizer and are therefore intended solely for the personal use of the Congress participant.
